PAWNBROKER'S APPLICATION:**

The Pawnbrokers Act R.S.O. 1990, Chapter P.6 requires that every pawnbroker shall give to the municipality security to the satisfaction of the municipal treasurer in the sum of \$2,000 for the due observance by the pawnbroker.

The City of Thunder Bay will accept a Notice of Bond Cost from an Insurance Company indicating the name of the Insurance Company; the bond period; the pawnbroker's bond amount, minimum of \$2,000; and a bond number, OR, an Irrevocable Letter of Credit from a Bank payable to "The Corporation of the City of Thunder Bay" indicating the bond period, the pawnbroker's bond as security in the amount of \$2,000 for the due observance by the applicant of The Pawnbrokers Act and, a bond number or account #. Copy of the Notice/Letter is to be submitted with the Pawnbroker's Application for License.

Example of Irrevocable Letter of Credit:

"It is a condition of this Letter of Credit that it shall be deemed to be automatically extended without amendment from year to year from the present or any future expiration date hereof, unless at least 30 days prior to the present or any future expiration date, we notify you in writing by registered mail that we elect not to consider this Letter of Credit to be renewable for any additional period." The Letter of Credit must include the bond amount and Bond # or Account #.
