SUBJECT: Request for Amendment to Fireworks By-law
Committee of the Whole – November 16, 2020

At the July 20, 2020 Committee of the Whole meeting, a resolution was passed directing Administration to report back with information and options for potential changes to the fireworks by-law.

Administration has provided a list of considerations to amend the by-law that include reducing the permitted days for discharge, sale, increasing awareness and reducing the number of named days.

As such, I provide the following motion for Council's consideration:

With respect to the Memorandum dated November 16, 2020 from Mr. D. Vincent, Manager – Licensing and Enforcement, we recommend that Administration amend Firework By-law 45-1993, as amended, as follows:

- Remove New Year's Day, Civic Holiday and Labour Day as permitted named-days;
- Permit discharge on only the named-day, removing the previously allowed three (3) days prior;
- Include a weather delay exemption; and
- Increase the set fines to the maximum out-of-court permitted amount;

AND THAT the by-law amendment be presented to Council on or before May 31, 2021.
