3.0 PRESENTATION – COMMUNITY SAFETY & WELLBEING PLANNING & CONSULTATION

Ms. L. Chevrette, Coordinator – Crime Prevention provided a PowerPoint presentation relative to the Crime Prevention Council and Community Safety & Wellbeing Planning.

A discussion was held relative to the following:

- Gang related crime
- Constituents feeling unsafe
- How to remove gangs from the City
- Lack of police presence
- Poverty/homelessness
- Improvements to mental health resources
- More efficient transportation for seniors
- Better safety for transit drivers
- Need for more resources for Thunder Bay Police Service

4.0 WARD AND CITY ISSUES

Lead Pipes

A discussion was held relative to lead pipes in older homes in the city. It was noted that the City will be providing water jugs and filters to all homes in the city that were a certain age with lead pipes. A discussion was also held regarding sodium hydroxide in city water and pin hole leaks in copper pipes. The Chair provided Ms. M. Warywoda's (Director – Environment) and Mr. T. Santos's (Manager – Compliance & Quality Control) contact information if any residents were interested in discussing the matter in more detail.

Newly Paved Section of Junot Avenue

A citizen voiced a concern regarding the newly paved section of Junot Avenue, and it being very bumpy. It was noted that there was only one coat of asphalt at this point, and the project was not complete.

Bus Stops on Walkover Street

A citizen voiced concern about a bus stop on Walkover Street, and how it pools with water. The Chair will follow up with Administration.
