- Have added Purpose as heading
- Objectives now considered Mandate
- New Terms will support implementation of Action Plan
- Promote .respect initiative
- Promote equity in community
- Summit instead of Roundtable on Racism (would be formed through action plan)
- Increasing community at large members from 5 to 7, including 2 Indigenous (First Nation, Metis, Inuit) Citizen Representatives; 2 BIPOC (Black, Indigenous, Person of Colour) or Racialized Citizen Representatives; 1 Female-identified Citizen

Representative; 1 2SLGBTQIA+ Citizen Representative; and 1 Ally Citizen Representative

- Council members reduced to 1, plus Mayor as Ex-officio (as per Report R 100/2021)
- Coalition of Inclusive Municipalities new name
- Ad-hoc working groups new section
