Notice Requirements

Schedule A

<u>How to use this Schedule:</u> Read across each row of the table to determine the Subject Matter for which notice is required to be given, the manner in which it must be given, and any additional requirements. The first column contains, written vertically, a heading to group similar Subject Matters together. It is there for ease of reference only.

The second column details the Subject Matter for which notice is required to be given.

The third column prescribes the manner in which Council requires the notice be given. Reference to Section 1 of the By-law is required to particularly define the "notice method". Note that the third column may have more than one requirement, in which case, all must be fulfilled.

The fourth (final) column provides any specific or additional notice requirements, including time frames, related to that Subject Matter.

<u>General Example</u>: reading across the table, you use the words in the column to fill in the parentheses in the following paragraph:

With respect to (insert words in "Subject Matter" column) notice shall be (insert the meaning for the words in "Notice Method" column) (insert words in "Special Provisions" column).

<u>Specific Example</u>: with respect to Subject Matter "Amendment of an existing licensing by-law that will affect license-holders", the requirement reads as follows:

With respect to the amendment of an existing licensing by-law that will affect license-holders, notice shall be mailed to all affected license holders two (2) weeks prior to the date of the meeting at which the Subject Matter is to be considered. The address for each license holder for the purpose of this notice is the address on file with the Manager of Licencing & Enforcement.

<u>Specific Example with more than one requirement</u>: with respect to Subject Matter "Permanent highway closings", the requirements read as follows:

With respect to permanent highway closings, notice shall be published in a Newspaper twice, once in each of two (2) successive weeks, prior to the date of the meeting at which the Subject Matter is to be considered <u>and</u> notice shall be placed electronically on the City Web Site continuously, for two (2) weeks prior to the date of the meeting at which the Subject Matter is to be considered.

Taxes

This notice must include: the amount that would have been payable without the phase-in, the amount of taxes that are payable and the difference.
2.	Notice of taxes due for prior year (per Subsection 348(2) of the Act)	Mailed	within five (5) days of the date of determination of the tax status, to every taxpayer who owes taxes, notice of the amount due, including related late payment charges and/or interest.
3.	Notice to Occupant that taxes are due (by the Property Owner) with respect to the occupied property (per Subsection 359(1) of the Act)	Mailed	upon determination by Treasurer that it is appropriate to attorn rents to pay outstanding taxes. The notice must specify that all future rent payments shall be made to the Treasurer rather than to the Property Owner until further notice from the Treasurer that attornment is no longer required.
4.	Notice of a meeting where the Council will consider an application for division of a tax account between legally conveyable land parcels (per Section 356 of the Act)	Mailed	to the applicants and the affected Property Owners on or before the twenty-first (21st) day prior to the date the meeting is to be held.

Notice of a decision made at a meeting where the Council considered an application for division of a tax account between legally conveyable land parcels (per Section 356 of the Act)	Mailed	to the applicants and the affected Property Owners within fourteen (14) days of the date of the decision. This notice shall specify the last day for appealing the decision.
6.	Notice of a meeting where the Council will consider an application for cancellation, reduction, or refund of taxes (per Section 357 of the Act)	Mailed	to the applicants on or before the twenty-first (21 st) day prior to the date the meeting is to be held.
7.	Notice of a decision made at a meeting where the Council considered an application for cancellation, reduction, or refund of taxes (per Section 357 of the Act)		to the applicants within fourteen (14) days of the date of the decision. This notice shall specify the last day for appealing the decision.

General

1.	Removal of Public Utility service (per Section 81 of the Act)	Mailed or Delivered or Posted	Owners and Occupiers ten (10) days prior to the cessation of the service. Notice shall include instructions on what to do to prevent cessation of the service.
2.	Agreements for municipal capital facilities (per Section 110 of the Act)	Mailed	to the Minister of Education, to the assessment corporation, to the clerk of any other municipality that would, but for the by-law, have had authority to levy rates on the assessment for the land exempted by the by-law; and to the secretary of any school board in the area of jurisdiction of the board that includes the land exempted by the by-law, all within five (5) days of the passage of the by-law authorizing the agreement.
3.	Information about how the Corporation provides notice to the public	City News and Online	once annually in September of each year (or, where there is no edition published in September, the edition first published after September). This notice shall specify where on the City Web Site to get information on how notice is sentcontinuously, at all times.
