A By-law to amend By-law 087-2007 with respect to Schedule "C" restrictions over 10,000 kg.

Recitals

1. It is deemed necessary and expedient to amend By-law Number 087-2007 being a by-law to regulate traffic on the roads and highways of The City of Thunder Bay, with respect to Schedule "C" (Restrictions over 10,000 kg) by Committee of the Whole Resolution dated November 1, 2021.

ACCORDINGLY, THE COUNCIL OF THE CORPORATION OF THE CITY OF THUNDER BAY ENACTS AS FOLLOWS:

1. THAT SCHEDULE "C" – 10,000 Kilogram Limit, is hereby amended by inserting therein, in columns herein set forth, in alphabetical order, the following Weight Restrictions:

<u>Highway</u>	<u>From</u>	<u>To</u>
East Avenue	Dawson Road	County Boulevard
Market Street	East Avenue	Wardrope Avenue

2. This By-law shall come into force and take effect upon the date it is passed.
