Potential Future Uses - Dease Pool/Park Site

Report No. R 174/2019 (Community Services - Recreation & Culture) recommending that subject to Council approval of the proposed 2020 capital budget, Administration proceed with the decommissioning and demolition of the former Dease Pool site at an estimated cost of \$260,000 and that Administration continue to deliver enhanced programming initiatives within the existing budget and/or the successful leveraging of funds acquired through partnership(s) or as a result of successful application to external sources. With respect to Report No. R 174/2019 Potential Future Uses – Dease Pool/Park Sites (Community Services – Recreation and Culture), we recommend that:

Subject to Council approval of the proposed 2020 capital budget, Administration proceed with the decommissioning and demolition of the former Dease Pool site at an estimated cost of \$260,000;

4.0 BRANDING, BANNERS AND PROMOTION

Ms. S. Levanen, Supervisor – Corporate Communications provided an update relative to the above-noted. RECOMMENDATION

With respect to Report No. R 174/2019 Potential Future Uses – Dease Pool/Park Sites (Community Services – Recreation and Culture), we recommend that:

Subject to Council approval of the proposed 2020 capital budget, Administration proceed with the decommissioning and demolition of the former Dease Pool site at an estimated cost of \$260,000;

AND THAT Administration continue to deliver enhanced programming initiatives within the existing budget and/or the successful leveraging of funds acquired through partnership(s) or as a result of successful application to external sources;

AND THAT Administration be directed to continue to consult with the community on a revised and more detailed concept plan for the Dease Park and Dease Pool sites, as suggested in this report, and report back on a proposed phased park re-development approach and financial implications in Q3 2020;

AND THAT as a result of more refined planning, Administration confirm whether the Dease Pool lands should be re-developed to meet the community's recreation needs or be declared surplus;

AND THAT, with respect to the memorandum from Mr. A. Cotter, Chair Heritage Advisory Committee (HAC), dated June 28, 2019, we recommend that as an alternative to designation, maintaining a similar community use of the Dease Pool property be explored, and a more refined concept plan of the Dease Park and/or Pool sites include commemoration of the cultural history of Dease Pool, and that the Heritage Advisory Committee be consulted on the form, content, and location of that commemoration;

EXECUTIVE SUMMARY

This report provides Council with information regarding proposed future uses of the Dease Pool/Park site based on developments arising since Council's approval to close the Dease Pool in 2018 (Report 124/2018) – specifically, the results of enhanced park programming delivered in the McKellar ward since spring 2019, recommendations from the Heritage Advisory Committee, and public feedback regarding a proposed Dease Pool/Park site re-development concept plan.

DISCUSSION

Enhanced Park Programming McKellar Ward - 2019

Administration consulted with residents of the Dease Park area community between February – March 2019 to inform the proposed enhanced park program plan for 2019. Based on an operating budget of \$52,000 and public input, staff delivered the following, new, complementary programming to the community surrounding Dease Park:

Scheduled Drop-In Programs - No Fees; Simple Registration Process

Target Age Group 5 - 12 years

- 1. Swim, Bike, Fun! in partnership with Eco Superior Thursdays, July August; Dease Park to Art Widnall Pool; 7 unique participants, 24 registrations.
- 2. Playgrounds Tuesdays & Thursdays, July August; Dease Park; 33 unique participants; daily attendance 0 19.
- 3. Playgrounds Mondays, Wednesdays and Fridays, July; Fort William Curling Club; 10 unique participants; daily attendance 0 2.
- 4. Kids Nights in partnership with several organizations Wednesdays, November December; McKellar Park School Gymnasium; results pending.

Target Age Group 12 - 18 years

1. Youth Move – Community BBQ in partnership with Science North and Evergreen a United Neighbourhood – Wednesdays and Fridays, July – August; Dease Park; majority of participants younger than target age group; daily attendance 0 - 8 with exception of Science North (50).

In addition, the following special events were delivered/are planned through the Recreation and Culture Division in partnership with others:

- 1. Family Skates Fort William Gardens April 15, November 2, December 7
- 2. Longest Day of Play Transit Shuttle to Canada Games Complex June 21
- 3. Movie Night Dease Park August 28
- 4. Fall Festival Dease Park September 28
- 5. Canada Games Complex Birthday Party Shuttle October 26

- 6. Paint Nite McKellar Park School Gymnasium November 16
- 7. Winter Wonderland McKellar Park School Gymnasium December 14

With the exception of the Canada Games Complex Birthday Shuttle, average attendance at events ranged from 100 - 200. The majority of participants were families with young children.

Events were also implemented by Councillor Hamilton and the Rebuild Dease Pool Group at the Dease Pool/Dease Park sites during this past year.

Based on the initial enhanced programming initiatives, staff have provided feedback. In general, successes included: consistent attendance by children and associated parental engagement for programs aimed at the 5 - 12 year age group; the neighbourhood's strong interest in special events that bring the community together; willingness of partners to support programming in this area; and the diversity of programming opportunities available. Challenges included the promotion of program opportunities to the neighbourhood; the limited park infrastructure (eg no running water or shelter in Dease Park, lack of onsite storage facilities for program equipment); and the limited participation of area youth (12 - 18 years).

Neighbourhood Demographics

To inform future park programming and the draft Dease Pool/Park concept plan, Administration reviewed the current and forecasted demographics for the area. Staff defined the approximate 1.29 square mile 'Dease neighbourhood' as being bounded by the McIntyre River to the north, May Street to the east, Victoria Avenue East to the south, and Waterloo/CN Rail Line to the west.

The 2019 population for this catchment area is estimated to be 3,744, representing 1,816 households with an average household size of 2.1 persons or 1,001 families with an average family size of 2.7. A minor decline in population, households and families is forecasted for 2024 (-0.10 percent decline).

The median, annual household income in 2019 is \$54,385 and the average household income is \$65,053.

First languages were identified by residents as English (90%), Aboriginal dialects (31%), and French (2%). Just under 7% of residents identified as being an immigrant. The most common ethnic origins identified were Filipino (49%), Southeast Asian (22%) and Latin American (12%).

Draft Concept Plan – Dease Pool/Park Site

To inform potential future uses of the Dease Pool/Park Site, Administration developed a draft concept plan for the Dease Pool/Park site to share with the public and obtain community feedback through various public engagement initiatives conducted October 24 – November 6. The draft concept plan was informed by: demographics of the population living in the Dease Park neighbourhood; the results of enhanced programming initiatives to date; and an assessment of the park/recreation infrastructure and deficits in the area. Refer to Attachment #1 – Draft Concept Plan Dease Pool/Park Site.

Administration explored potential future uses of both the Dease Pool and Dease Park area. The park was included in the concept plan because of the limitations that exist within the pool site alone – close to adjacent residences, arterial roads and the limited size of the Dease Pool site.

Dease Pool Site Proposed Changes:

- 1. Removal of the pool basin and change room and washroom building
- 2. Fenced outdoor tennis/pickleball court
- 3. Community garden
- 4. Shaded sitting area with cultural historic story panels
- 5. Edible fruit trees

The proposed site design is a mix of active and passive activities geared to the broad demographic making up the local community.

Dease Park Site Proposed Changes:

- 1. Removal of an existing half-court basketball area
- 2. Creation of a large, green open space
- 3. Boarded rink with lights, asphalt surface to support multiple activities in the summer
- 4. Permanent change room and washroom building
- 5. Playground infrastructure
- 6. Sitting area
- 7. Circular walkway path around the park
- 8. Trees to buffer active play areas
- 9. Crab apple trees
- 10. Enhanced traffic calming on Dease St. to connect the former pool site and park area.

Public Engagement Strategy

The public engagement strategy to acquire community input on the proposed concept plan for the Dease Park/Dease Pool site included the following:

- 1. Online survey through City's 'Get Involved' platform available October 24 November 11
- 2. Presentation at Heritage Advisory Committee Meeting on October 24
- 3. Two (2) in person 'Pop Up' sessions:
 a) Thursday, October 31 11:00 am 1:00 pm Village Green Victoriaville Mall
 b) Saturday, November 2 5:00 7:00 pm Fort William Gardens
- 4. Presentation at McKellar Ward Meeting on November 6.

A request to consult with students at the McKellar Park School could not be accommodated during the most recent public engagement timeframe. Additional promotion specifically targeting the engagement of older adults was completed through the 55 Plus Centre's email distribution list and newsletter.

The objectives of the public engagement sessions were to acquire feedback on the draft concept plan and proposed changes to the Dease Pool/Park sites, to acquire information on current and proposed visitation to the sites, and resident recreation preferences.

Results of Public Engagement

1. Online Survey Results

Attachment 2 - "Future Uses of the Dease Pool and Park Area: Survey Demographics" summarizes the profile of respondents to the online survey. Two hundred and twenty-three (223) respondents completed the online survey the majority self-identifying as being 18+ years and female. One resident who experienced a technical issue with accessing the online survey provided feedback via e-mail bringing the total 'online' respondents to 224.

Attachment 3 – "Survey Report: Potential Future Uses of the Dease Pool and Park Area" provides the results of the online survey. Respondents advised that the most popular activities they or a member of their family would participate in as a result of the proposed changes in the concept plan involved use of the boarded rink (winter)/asphalt surface (summer), a bigger playground, walkways, and the open space/play field area.

When ranking park amenities such as lighting, washroom/change building, trees, and shaded sitting area, respondents ranked good lighting as most important. Almost 2/3 (64%) of respondents wanted to see more safety features added to help cross Dease Street to connect the pool site and the park.

Approximately 82% of respondents thought that the community would benefit from continued recreation programming offered by the City of Thunder and partners, especially to children (5 - 12 years), youth (12 - 18 years), and families.

Respondents cited the following top three (3) priority types of activities:

1. child care/Kids' Club/Afterschool Program/Summer in the Parks Program

- 2. multi-sport/sports; play structure/swings (naturalized)
- 3. hockey/skating; basketball; splash pad.

In respect of programming options for youth (12 - 18 years), basketball and teen club/youth group were identified.

The top three (3) proposed activities for unspecified age group/all ages included swimming (21 respondents), skateboarding (13 respondents), and skating/hockey (9 respondents).

A summary of general/open ended comments received suggested that sixty-seven (67) respondents wanted a rebuild of the Dease Pool. Thirty-six (36) respondents suggested that the proposed tennis/pickleball court would not be well used. Thirty-three (33) respondents expressed interest in a skate park and twenty (20) respondents expressed interest in a splash pad.

While a slight majority (44.1%) of respondents said they were very happy or happy with the proposed changes to a re-designed Dease Pool/Park area, 17.6% stated they were neutral, and 38.3% responded that they were unhappy or very unhappy.

4. **Pop-Up Sessions Feedback**

Approximately 25 – 30 people attended the two (2) in-person 'Pop Up' sessions to provide feedback to staff. The results are summarized in Attachment 4 - "Dease Pop Up Feedback." Similar to online survey respondents, approximately half of participants currently use Dease Park. The majority of participants supported the proposed boarded rink (winter)/asphalt surface (summer). A bigger playground received the next highest votes. Support for a community garden was identified as the third priority at the October 31 pop up session only. Twenty participants (20) voted for a pool.

Lighting was identified as the most important park amenity, followed by a washroom/change building. A majority supported more safety features to facilitate crossing Dease Street and connecting the pool site to the park.

Participants of the October 31 session mainly supported organized recreational programming for children and older adults. Specific programming for children requested included summer camps, swimming, and developmental programming/accessibility. Programming requests for older adults included yoga and programming for Indigenous older adults. Forty-six percent (46%) of participants stated that they were happy or very happy with the proposed changes; 15% stated they were neutral; and 38% stated they were unhappy or very unhappy. General comments received questioned the use of proposed tennis/pickleball court by urban youth and a request to rebuild the pool.

Participants of the November 2 session for the most part requested 'Save' or 'Rebuild' Dease Pool for all age groups. The majority of participants were either unhappy or very unhappy about the proposed changes. General open comments received requested a rebuild of the pool.

Potential Future Uses of Dease Pool/Park Site

Overall, the community supports the following proposed changes to Dease Park:

- 1. Boarded rink with lights, asphalt surface to support multiple activities in the summer
- 2. A bigger play structure
- 3. The need for walkways
- 4. Preservation of a large, open green space
- 5. Traffic calming on Dease St. to connect former pool site to park area (if pool site required).

Staff have identified the importance of an amenity building with running water, accessible washrooms, open space that could double as a place to put on/take off skates, provide sheltered program space, and provide supply/equipment storage.

Administration recommends consideration of portable skateboarding components that could be placed within the boarded rink/asphalt surface to be located in Dease Park, subject to confirming suitable storage. Onsite storage capacity would likely allow for more flexible use of the pad and provide for easier set up/take down of portable skateboard components.

As there is an existing splash pad at nearby Franklin Park (1.9 km away) Administration does not recommend consideration of a splash pad at Dease Park. Council recently resolved as per Report 120/2019 - Splash Pad Priorities (Infrastructure and Operations – Parks and Open Space) to move forward with a spray pad at the Northfield Playfield and to conduct further planning and public consultation to inform the selection of two final splash pad locations to provide effective delivery of summer aquatic opportunities and report back to Council. The list of 11 potential candidate sites, informed by coverage area, demographics, population and supporting amenities, does not include the Dease Pool site. Administration could explore an opportunity to incorporate a new, water play feature into the proposed extended play structure at Dease Park.

Administration cautions against the installation of a skateboard plaza and/or spray pad at the current Dease Pool site based on potential incompatibility with adjacent residences, the anticipated additional measures/capital costs to mitigate anticipated concerns, and the opportunity to address these needs through the adjacent Dease Park.

If Council and the community are supportive of addressing skateboarding and water play through proposed re-development of Dease Park, there are at least 4 options for the Dease Pool/Park sites. Please refer to Attachment 5 – "Detailed Financial Implications – Potential Decommission/Improvements to Dease Pool/Park Sites".

Option A: Decommission/Demolish Dease Pool – Restore Dease Pool Lands to support Passive Park Activities (Approximate capital cost of \$537,050; \$2,000 additional annual operating costs)

This option involves the decommissioning and demolition of the existing Dease Pool and change room building at an estimated capital cost of \$260,000 and restoration of property to

accommodate more passive recreation/leisure activities at an estimated capital cost of \$277,050 for a total estimated capital cost of \$537,050. Further community consultation would be required to affirm a more detailed concept plan/specific park infrastructure required to support passive activities. However, the proposed capital costing to re-develop the Dease Pool site under this option has included the installation of a shaded seating area, concrete walkways/sod, lighting, litter and recycling containers, fruit trees, a garden, soil, traffic calming measure to cross Dease Street and connect the former Dease Pool site to Dease Park, and a commemorative plaque to recognize the historical, cultural significance of Dease Pool as per Heritage Advisory Committee (HAC)'s Option 2 recommendation discussed below.

The property would be maintained as City-owned parkland. In respect of annual operating budget implications, Parks and Open Space identified the need for an additional \$2,000 per year to maintain the proposed garden, fruit tree planting, sod and pay utility expenses.

Option B: Decommission/Demolish Dease Pool – Restore Dease Pool Lands and declare Surplus (Approximate net capital cost of \$100,000)

This option would decommission/demolish the Dease Pool and change room building, declare the property as surplus, and restore the property to a state that is ready for re-purposing/resale. As per Report 124/2018, the estimated resale value of the Dease Pool site is \$160,000-\$180,000. Administration believes that commemoration of the Dease Pool site could be accommodated at Dease Park. However, Administration would seek HAC's comments on this option.

Option C: Decommission/Demolish Dease Pool – Redevelop Dease Park (Approximate capital costs of \$1.5 million; \$25,000 additional annual operating costs)

In addition to the decommission and demolition of the Dease Pool and change room building on the Dease Pool site property, this option proposes the redevelopment of Dease Park to support enhanced park programming as per favourable feedback received through the public engagement process. This option includes the removal of some existing park infrastructure to support the redevelopment (eg removal of existing basketball court, concrete walkways, existing trees as required, existing light poles and fixtures). Proposed new installations include: asphalt permanent boarded rink with lights; playground expansion with safety surface; concrete walkways and sitting area; a new amenity building; Dease Street traffic calming; new light pole fixtures, electrical, metal benches, litter and recycling containers; restoration of open playfield space, including top dressing; provision for the introduction of a new, water play feature as part of the playground expansion in response to community feedback; a commemorative plaque; and, potentially, the introduction of new, portable skateboard components that could be placed on the boarded rink between spring to fall. Additional consultation would be required in relation to the commemoration of the Dease Pool site at the Dease Park location, the proposed water feature, and the accommodation of skateboarding in a re-developed Dease Park (portable skateboard park components have not been accounted for in the capital cost estimate).

Should Council support a proposed re-development of Dease Park, there would be an opportunity to phase the re-development. A capital project of \$210,000 to advance recommendations in the Recreation and Facilities Master Plan has been included in the 2021

capital forecast. Parks and Open Space has advised that the re-development of Dease Park is not aligned with Council and/or departmental strategic priorities.

In respect of annual operating impacts related the proposed Dease Park re-development only, an additional \$23,500 would be required to support ice rink maintenance (flooding, snow removal, inspections), utilities (amenity building), and, extended playground maintenance. This costing assumes no other expansions to the City's outdoor rink program. An additional \$4,500 every 3 years would be required to maintain the asphalt surface contained in the boarded rink. Access to the amenity building would be dependent on the provision of supervised activities available through Recreation and Culture and/or potentially qualified programming partners.

Option D: Rebuild Dease Pool (Approximate capital costs of \$2.81 million; \$45,000 additional annual operating costs)

A rebuild of the Dease Pool would be an option for the Dease Pool property. As stated in Report 124/2019, the estimated capital cost to replace the outdoor pool and update the change room facility to meet current day requirements is \$2.81 million. In addition, there would be a need to reinstate an annual operating budget of \$45,000 for pool maintenance.

Administration does not recommend a rebuild of the outdoor pool given the existing capacity provided through nearby aquatic venues to meet bather needs, the limited value offered through a new seasonal, outdoor venue, competing recreation and municipal infrastructure priorities, and, potential challenges in securing qualified lifeguards to support the operation.

Heritage Implications

Dease Pool is listed on the City's Heritage Register as a property of interest but has not been formally designated under Ontario Regulation 9/06 of The Heritage Act.

Properties listed on the Heritage Register (but not formally designated) have the following protections:

- 1. No demolition permit can be issued for 60 days from application.
- 2. During that 60 day period the designation process could be initiated by Council ratifying a recommendation from HAC to designate the property.
- 3. Once the designation process starts no demolition permit can be issued until the designation process has run its course.
- 4. Application for a demolition permit automatically triggers referral to HAC from Building Services.

At the request of citizens attending HAC in January 2019, HAC agreed to evaluate whether the Dease Pool would qualify for designation. On May 23, 2019 HAC accepted the findings of an evaluation sub-committee that Dease Pool qualified for designation. HAC passed two resolutions with respect to Dease Pool. These two resolutions are reflected by the memo from HAC Chair Mr. A. Cotter, dated June 28, 2019, distributed to Council at their July 29, 2019 Committee of the Whole meeting. (Reference Attachment #6 – "Memo to Council, July 29

COW, from Chair Heritage Advisory Committee, A. Cotter, Dease Pool - Heritage Designation".) This memo proposed the following two motions for City Council's consideration:

- 1. With respect to the memorandum from Mr. A. Cotter, Chair Heritage Advisory Committee, dated June 28, 2019, we recommend that the Heritage Advisory Committee proceed with the designation of the property known as Dease Pool for its cultural and heritage significance as defined by Part IV of the Ontario Heritage Act.
- 2. With respect to the memorandum from Mr. A. Cotter, Chair Heritage Advisory Committee, dated June 28, 2019, we recommend that as an alternative to designation maintaining a similar community use of the Dease Pool property be explored; and that the site be commemorated with a plaque.

Option 1: Designation Dease Pool Site

If Council votes to proceed with the designation of the Dease Pool property, then Council would serve notice that it is proceeding with designation. The notice provides for objections to the designation to be received within 30 days. If there are objections, they are referred to the Conservation Review Board. The Conservation Review Board's report is presented to Council. Council decides if it will proceed or not with designation. If Council decides to designate, a designation bylaw is passed and the property is then listed on the municipal and the provincial heritage register. The consequences of a property being listed on the Heritage Register are:

- 1. Applications for building permits and demolition permits will be flagged to HAC (the demolition permit condition already exists by virtue of the property being listed on the Heritage Register).
- 2. Community Services and/or any future property owner would have to consult with HAC on any substantive modifications to the property.

Option 2 – Exploring Continued Similar Use for the Property and Commemoration with a Plaque

Under this option, HAC recommends maintaining a similar use for the Dease Pool property and commemorating the history of Dease Pool through signage that combines text telling the pool's history with historical photographs. The signage would be similar to that erected around the City by the Museum several years ago.

If as a result of further community consultation and a refined plan for the proposed redevelopment of Dease Park, the Dease Pool sites are declared surplus, Administration invites comment from HAC regarding the proposed commemoration of the Dease Pool site in Dease Park.

In consultation with Administration, Option 2 is recommended for Dease Pool to provide for a similar use for the property and for commemoration of the cultural history of the Pool. This direction has been incorporated into the overall recommendation within this report.

FINANCIAL IMPLICATION

The proposed 2020 capital budget includes the decommissioning and demolition of the former Dease Pool site, at an estimated cost of \$260,000 to be funded as a tax supported project.

CONCLUSION

It is recommended that Council direct Administration to proceed with the decommissioning and demolition of the Dease Pool and existing change room facility in 2020 as proposed in the 2020 capital budget. In addition, it is recommended that Council direct Administration to continue with community consultation and the development of a refined concept plan for a re-developed Dease Park, considering the potential for the Dease Park to accommodate the community's request for skateboarding and water play facilities, and to report back by Q3 2020. As part of this report, Administration should report back on future potential uses of the Dease Pool site and/or whether the property could be declared surplus to meeting the City's recreation needs. Finally, the revised plan for the Dease Park and Pool sites should include a commemoration of the Dease Pool's cultural and historical significance and that the Heritage Advisory Committee should be consulted on the form, content, and location of that commemoration.

BACKGROUND

In December 2018, Council approved Report 124/2018 – Enhanced Park Programming and Dease Pool (Community Services – Recreation and Culture) which directed the closure of the 106-year-old facility which had reached the end of its lifecycle, was in very poor condition, presented various safety risks, did not meet current day aquatic facility standards, and attracted on average one-third of the attendance of other nearby outdoor pools. In addition, Council approved a re-direction of the majority of the existing pool operating budget (\$52,000) to support the implementation of enhanced park programming to address the recreation needs of the community. The report also spoke to the estimated costs to decommission/demolish the pool and change room building (\$360,000) and rebuild the pool and change room building to current standards (\$2.81 million).

Deputations were made to City Council after Council's consideration of this report and during the 2019 budget deliberations, expressing concern about the pool closure. Council requested Administration's comments regarding two unsolicited proposals to rebuild the pool which were presented as having lower capital costs of construction. Administration advised Council that the capital cost of construction per square foot for each proposal was the same or higher than that provided to Council in Report 124/2018 when one compared the reduced size of pool basin and/or assessed areas where the proposal would not comply with municipal/provincial requirements. Council affirmed their earlier decision to proceed with the pool closure and directed Administration to implement enhanced park programming in 2019 based on consultation with the community and report back on potential future uses of the Dease Pool site.

On January 24, 2019 a group of citizens made a delegation to a Heritage Advisory Committee (HAC) meeting with respect to having Dease Pool designated as a property of cultural heritage value. HAC formed a sub-committee to study the appropriateness of designating Dease Pool through its established evaluation tool. The HAC sub-committee found that Dease Pool qualified as a property that should be recommended for designation. HAC passed two resolutions as reflected in a memo from HAC Chair Andrew Cotter, dated June 28, 2019, distributed to Council at the Committee of the Whole meeting on July 29, 2019.

On July 22, 2019 City Council approved that the next priority location for a proposed spray pad should be the Northwood Playfield (Report No.120/2019 - Infrastructure & Operations – Parks & Open Spaces) and that a listing of 11 potential candidate locations be assessed for their potential to accommodate two additional community urban focused spray pads. The Dease Pool/Park area is not included as a candidate location.

In March 2010, City Council accepted the HAC's recommendation that Dease Pool be listed on the City's Heritage Register as a property of interest (Corporate Report 2010.068 – Office of the City Clerk). The property was not formally designated under Ontario Regulation 9/06 of The Heritage Act.







Q3 What park amenities are most important to you? Rank in order of importance. (1 being highest priority, 4 being lowest)





Q4 How often would you use the Dease Pool/Park area if the proposed changes were made?




Q5 Do you think more safety features should be added to help cross Dease Street connecting the pool site and the park?







There should be a good playground in addition to the programming provided by City Playground leaders and invited leaders. Some activities should celebrate the rich diversity of our community so that all young people feel comfortable and part of Thunder Bay. That is where the placement of a small heated swimming pool in place of the proposed tennis court would be the best choice. We need more activities that do not need partners or groups to play like some of the suggested sports (Tennis, Basketball, and Pickleball require.) Children need activities that can be enjoyed by one child or a group of very young children and the Draft plan seems to have a heavy emphasis on Youth in the suggestions. If you study the demographics of the area you will find there are many young children in the area from families and single-parent families who would like to use a safe play space closer to their homes taking into consideration the lower incomes of many of these families. Tennis and Basketball in large areas as proposed are not well suited to little children but more to youth 12+. I believe the greatest need is for the City to be serving families, children, and Seniors who may have problems walking to other areas in our city or affording costs related with getting to these areas. There are many tennis courts (many seldom used even now), skate parks and activities for Youth but they would also benefit from learning how to swim in a small heated pool as would Seniors and what a great way to exercise by yourself or in the company of friends if the pool were placed where the suggested Tennis Courts are in the Draft Plan. For people of all ages, I suggest a spot to play that can be converted into an ice rink ideal for Skating in the winter, and this can be an INDIVIDUAL sport for children, Seniors, and Youth as well. I recall using a chair to learn how to skate and this remains one of my favourite activities to this day. There is mention of a Change Room and Washrooms and my concern is that the Washrooms currently located at Marina Park are closed most of the time especially during Live on the Waterfront when only port-apotties are available. Will this issue arise for the same reason...not certain what that reason is but there must be one...so unless tied to a fenced in Pool I don't know how feasible that idea is. I like the idea of flowers and trees but do not suggest Crab trees (have one in my yard) which require a lot of maintenance....causing slips and falls, and attracting animals causing problems when the apples fall. Fruit trees with edible fruit could cause similar problems. My biggest concern would be allergies if people eat the fruit...would they sue the city...just concerned. The community garden if manned may work and I recommend connecting with Roots to Harvest for advice. The sitting area would be good but added picnic tables would be

ideal for groups, families and craft and game activities. We certainly cannot afford to do all of this but I would like to see a small swimming pool where individuals of all ages can enjoy healthy fenced activities individually or with families or with friends, and where they can learn how to swim and make lifelong friendships as I did at Dease Pool, as part of this Plan, and an active Playground Leader program in Dease Park itself in the summer for children and Youth. Schools provide many after school activities during the school year, but we need a plan to ensure happy safe children are positively occupied in the summer months. If we give our children positive experiences early in life there are great possibilities that they will continue on this path and grow up to be strong community youth able to resist gang life an attraction as they grow. Having a park with a good playground and sitting area is also good for other parts of the year for people of all ages. Older adults can swim, walk, do yoga, play cards, read, and do a host of good activities in a friendly park...but don't forget we are often on our own and swimming is one activity we can enjoy not just for our health but because we can do it individually. My suggestion is that you reconsider a small heated healthy fenced pool as part of this plan and continue the good Playground Programs that were introduced this past summer. A good start that can grow with each added summer. Our community will be a better place if we make the Park and Pool positive places for families, children and Seniors.

Social drop in for seniors. Most places in town only have programs for seniors who are active, leaving nothing for seniors with limited mobility/limited social opportunities. No one needs a tennis court. Every tennis court that I can think of in the city sits unused and overgrown eventually to be removed or abandoned. Our weather here is only nice enough for perhaps 5 weeks for outdoor pickle ball so a te bus/pickle ball court is a huge waste of time and does nothing for little kids. 

concerns were initially identified, a decision was apparently made at some point to do only the minimal amount of work needed to keep the operation going, such as reparging/sealing the basin while opting to delay pursuing any major work until the situation could be "studied". This study became the catch-all excuse whenever the subject of renovations/reconstruction for the pool came up for discussion. "Oh, we don't think we have enough information to make an informed decision and we have to study the matter further." Delay after Delay, after DELAY. Deferred back to committee repeatedly. Allowed to sink in priority as other, so called "far more important" projects were pushed ahead of it and given higher emphasis in council meetings and sessions. Until last year when ignorance and avoidance had finally allowed the pool to become so decrepit that it could finally be condemned. In the private sector, companies and institutions that allow their facilities to become obsolete and valueless tend to disappear, over run by newer, more relevant, and up-to-date replacements. Here, a closed sign just gets stapled to the fence, the property is allowed to molder for a while, and then it is quietly put up for auction. As to the accusation of excessive noise, the pool is open only during the day, not at night. Children do tend to express themselves by both talking loudly and screaming in glee when they are having fun. The immediately adjacent neighbourhoods and the pool existed in harmony for many generations prior to now, it is only within the last generation or so that the noise of children playing seems to have become politically incorrect or unacceptable to nearby ears. It is important to appreciate the extent of the area that this pool serviced during its operational lifetime. While that area is basically encompassed by Northern Avenue in the North. Waterloo/Balmoral Avenue in the West, Victoria Avenue in the South, and May Street in the East, these streets are only the nominal boundaries. In my generation it was not uncommon for kids to travel from farther away to make use of the pool. As a source of amusement and diversion, that pool ranked as both the greatest and cheapest form of entertainment that a child could wish for. As the demographic mix of the adjacent neighbourhoods changed, the pool remained the same, open to all with malice towards none. That pool served a vital purpose that continues to exist, a purpose that Pickle Ball and Tennis do not even start to answer. These are both high value sports that require a high buy-in in order to enjoy. For swimming, by contrast, you can get away with a Tee-shirt and hacked up blue jeans, both items readily to be found in the old clothes hamper, or you can visit one of the discount stores and score an offshore made garment for far less than the cost of a tennis racket or a pickle ball paddle. By all means, if access to the pool is deemed to be a traffic concern, then address the matter of the traffic; but do remember that Vickers Street, for all its pedestrian trappings, is a North/South Arterial on which Is located both the primary detachment of our City's Fire Department as well as adjuncts of our EMS ambulance service, and any restriction on their ability to rapidly deploy and reach out to serve the public must not be constrained. Summarily, rather then being commended for its astute stewardship of our city's infrastructure, Planning and Development, and by extension, City Council as a whole, should be censured vigorously for their

collective failure to deal with this matter in a more proactive and timely fashion. As noted earlier, this is civic action at its local finest, dithering and delaying until time renders the need for decision and commitment moot or unnecessary. As a final thought on this matter, all of the courts under consideration, pickle ball, tennis, and basketball, would require a hard surface that, typically, is created by applying a layer of asphalt to a prepared substrate. Since when has asphalt become environmentally friendly or ecologically acceptable? We tolerate it for roads because it is cheap and easy repaired when damaged by frost and salt. The Heritage Advisory Committee put the Dease Pool property through its established Cultural Heritage Property Evaluation System to assess its potential for designation under the Ontario Heritage Act. Under Ontario Regulation 9/06 a property can be designated if it meets one or more of the following criteria of cultural heritage value:

- 1. It has design or physical value;
- 2. It has historical or associative value;
- 3. It has contextual value.

The Heritage Advisory Committee's evaluation concluded that Dease Pool should be considered for designation because it scored high on contextual value and intermediate on historical or associative value. It scored low on design or physical value. The overall score of 93 out of a possible 180 points indicates that it should be considered for designation.

The Dease Pool Property - Cultural Heritage Evaluation Summary Report is attached. The full report is available through the Office of the City Clerk.




Figure 1 Dease Pool ca.1911 TBA 1991-1-259

Executive Summary

Thunder Bay City Council passed a motion to close Dease Pool at the December 10, 2018 Committee of the Whole meeting, this motion was ratified at the City Council meeting on December 17, 2018. Local citizens, concerned with the closure, began petitioning city council and also appeared before the Heritage Advisory Committee (HAC) at the Thursday, January 24, 2019 meeting.

At that meeting, HAC agreed to put the Dease Pool property through its established Cultural Heritage Property Evaluation System to evaluate the pool and further assess its heritage value. A sub-committee was struck to complete this evaluation for potential designation under the *Ontario Heritage Act*. The Dease Pool property had previously been identified as having heritage value and was listed on City of Thunder Bay's Heritage Register in 2010.

Sub-committee members have met and completed their assessment of the Dease Pool property using the established Cultural Heritage Property Evaluation System. The sub-committee further developed this report to provide the "Results of Evaluation", identify applicable heritage policies, and provide summarizations of geographic and historical context of the area including Dease Pool itself.

The checklist completed by the sub-committee indicated that the Dease Pool property warrants consideration for heritage designation. As the Dease Pool property met at least one criterion outlined in the Cultural Heritage Property Evaluation System (Feb. 21, 2019), it is eligible for designation under the *Ontario Heritage Act*. As the values exhibited by the property are primarily associative and have limited ties to the design or physicality of the structure there are few physical heritage attributes that express the value of the property. A Statement of Cultural Heritage Value has been prepared. Therefore, the following recommendations should be considered to determine the future of the property:

1. Maintaining a similar community use for the property should be explored;

2. Commemoration of the site, including a plaque, should be undertaken using the research uncovered in the Cultural Heritage Evaluation Report;

3. Cultural Heritage Evaluation Report should be submitted to City Administration after ratification by the Heritage Advisory Committee.

Evaluation of Cultural Heritage Value or Interest

Taking into consideration the historical research and reports, a sub-committee of the Heritage Advisory Committee evaluated the Dease Pool property using the scoring system previously created by HAC known as the Cultural Heritage Property Evaluation System, revised October 2016. This evaluation system was established to determine Cultural Heritage Value or Interest as set in O. Reg. 9/06. The subcommittee evaluated the Dease Pool property, creating the basis for this report, during meetings held March 8 and March 14, 2019. The report is a consensus based on analyses of 3 sub-committee members. (L. Abthorpe, Heritage Researcher, acted as secretary for the sub-committee and did not submit towards the evaluation.) Based on the evaluations of the sub-committee, L. Abthorpe produced this evaluation report. A site visit was completed on April 18, 2019.

Statement of Cultural Heritage Value

Dease Pool Property, 370 Vickers Street North, Thunder Bay

Dease Pool property is an outdoor public swimming pool located at the corner of Vickers Street North and Dease Street in the former city of Fort William now the city of Thunder Bay.

The Dease Pool property's cultural heritage value lies mostly in its context within the community. In 1909, the Fort William Board of Education appeared before City Council to discuss the necessity of a public swimming pool in order that swimming become part of the public school curriculum, with the goal of eliminating downing incidents in local waterways. By June of 1910, the established Swimming Pool Committee which included members of City Council, the Board of Trade, the Board of Education and the Separate School Board, began construction of a swimming pool in Fort William. In order to move forward with the project right away, forty citizens guaranteed \$10,000 by each signing a \$250 bond enabling the City to secure funds from a bank until such time as the debenture passed by by-law.

Dease Pool was completed and opened to the public in July 1911. The new pool became very popular very quickly and has remained so over the years. Threat of closure in the late 1970's faced strong objection from the surrounding community, which fought successfully to keep Dease Pool open along with the commitment to renovate.

Marking 107 years of age in 2018, Dease Pool property is the longest surviving public pool in the city of Thunder Bay. The original footprint of the pool remains unchanged, though in 1983 a fiberglass coating was added to the pool's concrete floor and retaining walls. Dease Pool property is a significant landmark within the surrounding neighbourhood and has continuously served as a summer meeting place for many local youngsters and their families. The property has value for its social function.

Conclusions and Recommendations

As the Dease Pool property met at least one criterion outlined in the Cultural Heritage Property Evaluation System (Feb. 21, 2019), it is eligible for designation under the *Ontario Heritage Act*. As the values exhibited by the property are primarily associative and have limited ties to the design or physicality of the structure there are few physical heritage attributes that express the value of the property. A Statement of Cultural Heritage Value has been prepared.

The associative value of the Dease Pool property derives from its use by the community for recreation purposes since the property began development in 1910. The contextual value of the property derives from the fact that there has been a pool associated with this property for the use by the community since the property began development in 1910. There is limited heritage design or physical value in the structures that currently exist on the property.

Using the Evaluation Tool, this property hit a high score in contextual value and an intermediate score in associative value.

Therefore, the following recommendations should be considered to determine the future of the property:

1. Maintaining a similar community use for the property should be explored;

2. Commemoration of the site, including a plaque, should be undertaken using the research uncovered in the Cultural Heritage Evaluation Report;

3. Cultural Heritage Evaluation Report should be submitted to City Administration after ratification by the Heritage Advisory Committee.

RECOMMENDATION

With respect to Report No. 184/2019 (Community Services – Recreation & Culture), we recommend that \$19,807.76 be allocated from the 55 Plus Centre Food Program Reserve fund via appropriation #26 for half of the total cost of the renovation of the outdoor patio and pergola and construction of a new garbage/recycling shed;

AND THAT \$10,000 be allocated from the 55 Plus South Side Centre Reserve Fund via appropriation #26 for purchase of program equipment;

AND THAT any necessary By-law updates be presented to City Council for ratification.

EXECUTIVE SUMMARY

The purpose of this report is to seek approval for use of funds from the 55 Plus Centre Food Program Reserve Fund to contribute to capital projects, and for use of funds from the 55 Plus South Side Centre Reserve Fund for purchase of program equipment, as recommended by the associated Boards.

In accordance with the associated Reserve Fund By-laws, Council approval is required for access to these funds.

DISCUSSION

55 Plus Centre

In 2019, the Board of Directors of the 55 Plus Centre Board and the 55 Plus Centre Food Board jointly approved plans and contribution commitments for renovation of the Centre's patio and pergola and construction of a new garbage/recycling shed. These projects are supported by Administration.

The patio and pergola project includes re-levelling of lock stone to eliminate the flow of water into the building lounge area, a new roof for the pergola to eliminate water build up that was resulting in mold and residue concerns, and coating of the pergola's lattice and beams to preserve the structure. The total cost of this project is \$17,351.15, split equally between the two Boards.

The garbage/recycle shed project includes construction of a new shed to eliminate the use of a dumpster that costs the Centre a monthly dumping fee. Having this structure allows the City sanitation workers to pick up the garbage and recycling without any additional monthly operating cost to the Centre. The total cost of this project is \$22,264.37, split equally between the two Boards.

The 55 Plus Centre Board of Directors are contributing the necessary funds from their trust account to cover their portion of these two projects. The 55 Plus Food Program is requesting Council's approval to access to the Reserve Fund for their program to cover their share of the two project costs, totaling \$19,807.76.

West Arthur South Side Seniors Centre

The West Arthur Community Centre Board is requesting access to \$10,000 from the 55 Plus South Side Centre Reserve Fund to contribute to purchase of equipment such as a floor scrubber, computer, sound system, and tables. The equipment purchase is anticipated to cost approximately \$20,000, with \$10,000 funded by a Seniors Active Living Centre grant and the remaining \$10,000 to be funded by the Board from the reserve fund. These purchases are supported by Administration as necessary for the efficient and effective operation of the Centre.

FINANCIAL IMPLICATION

The financial implication of this request is \$19,807.76 to be funded from the 55 Plus Food Program Reserve Fund and \$10,000 to be funded from the 55 Plus South Side Centre Reserve Fund in 2019. Should Council approve this request, the uncommitted balance in the 55 Plus Centre Food Program Reserve Fund will be \$44,286 and the 55 Plus Southside Centre Reserve Fund will have an uncommitted balance of \$126,422.

CONCLUSION

It is concluded that the repairs to the 55 Plus Centre patio and pergola and the construction of the garbage/recycle shed represent improvements to the 55 Plus Centre and that the purchase of program equipment for the West Arthur 55 Plus South Side Centre is necessary for efficient and effective operation of the Centre. It is further concluded that these projects are supported by Administration and the associated Boards, that these projects are within the stated purpose of the relevant Reserve Funds, that the associated Boards are requesting access to these Funds, and therefore that the allocation of \$19,807.76 from the 55 Plus Food Program Reserve Fund and \$10,000 from the 55 Plus South Side Centre Reserve Fund should be approved.

BACKGROUND

The Thunder Bay 55 Plus Centre is a City-owned facility that is operated by the City of Thunder Bay with the assistance of two advisory boards, the 55 Plus Centre main Board and the 55 Plus Centre Food Program Board. The Centre has been in operation since September 1992.

The City of Thunder Bay pays all operating costs including, maintenance expenses, utilities and is responsible for all major repairs and capital repairs to the facility. The facility is operated by City of Thunder Bay employees with the assistance of the Boards and numerous volunteers of the Centre.

The West Arthur 55 Plus South Side Centre is also a City-owned facility that is operated by a Board of Directors for the Community Centre programming and by the City of Thunder Bay Older Adult Unit for Older Adult programming that operates from that Centre on Monday to Friday from 8:30 a.m. to 4:30 p.m. Outside of these operating hours, the Board of Directors is responsible for the operation of the centre. The City of Thunder Bay pays all operating costs including insurance, maintenance expenses, and utilities, and is also responsible for all major repairs and capital repairs to the facility.

Council approval is required to spend funds from the Reserve Funds established for each of the Boards.

RECOMMENDATION

With respect to Report R 156/2019 (Corporate Services and Long Term Care – Financial Services) and 2019CLS.035 (Corporate Services and Long Term Care), we recommend that the revised Tbaytel Dividend Policy as contained within this report and encompassing three major elements (a Fixed Annual Dividend, a Performance Dividend and a Special Dividend) be approved;

AND THAT the revised Dividend Policy serve as a direction to the Tbaytel Municipal Services Board for purposes of payment of future Dividends to the City of Thunder Bay;

AND THAT a review of the Tbaytel Dividend policy be undertaken every two years;

AND THAT the next review occurs in conjunction with the 2021 Third Quarter update from Tbaytel;

AND THAT the Annual Fixed Dividend in excess of \$17.75 million be transferred to the General Capital Reserve Fund;

AND THAT the Performance and Special Dividends continue to be directed to the Renew Thunder Bay Reserve Fund;

AND THAT any necessary by-laws be presented to City Council for ratification.

EXECUTIVE SUMMARY

The purpose of this report is to provide information regarding the current Dividend Policy for Tbaytel and to make recommendations for revisions to the policy.

The report also makes recommendations on the use of Fixed Annual Dividend in excess of \$17.75 million and future Performance and Special Dividends from Tbaytel by the City.

DISCUSSION

Current Dividend Policy

The current Tbaytel Dividend Policy was reconfirmed in 2017 and encompasses three components:

Fixed Annual Dividend

The Fixed Annual Dividend (\$17.5 million in 2018 and 2019) flows quarterly to the City. The amount in excess of \$17 million is transferred to the Stabilization Reserve Fund.

Performance Dividend

An annual Performance Dividend to the City of 25% of net income over approved plan is paid following the finalization of year-end financial reporting. There were no Performance Dividends declared in 2018.

Special Dividend

Following an annual review of both the retained earnings and free cash generated, the Board of Directors of Tbaytel may declare any available retained earnings as a Special Dividend at the Annual Members meeting or a Special Members meeting. The declaration of a Special Dividend by the Board makes certain that maximum return on investment is received by the owner.

In 2019, Tbaytel declared a Special Dividend of \$0.5 million of which \$0.265 million was included in the 2019 operating budget as general corporate revenue to reduce the tax burden (total general corporate revenue in 2019 budget - \$17.265 million) and \$0.235 million was transferred to the Renew Thunder Bay Reserve Fund.

Proposed Dividend Policy

In December 2017, City Council recommended that Administration review the Dividend Policy every two years and report back to City Council.

Further to Report No. 2019CLS.035 (Corporate Services and Long Term Care), it is recommended that the Dividend Policy be amended to increase the Fixed Annual Dividend to \$18 million for the years 2020 to 2023, and that the annual amount in excess of \$17.75 million be transferred to the General Capital Reserve Fund. The previous Dividend Policy recommended that the amount received in excess of \$17.0 million be transferred to the Stabilization Reserve Fund. The purpose of this reserve fund is to provide a source of funding in the event that uncontrollable or unanticipated costs or decreased revenues impact operating budgets. The uncommitted balance in this reserve fund is currently \$9.2 million providing a good degree of protection against these risks. As a result, Administration is recommending that the amount in excess of \$17.75 million be transferred to the General Capital Reserve Fund to work towards addressing the infrastructure deficit. This reserve fund is available to provide a source of financing for future capital requirements and currently has an uncommitted balance of \$0.77 million.

FINANCIAL IMPLICATION

The Fixed Annual Dividend of \$17.75 million will be included as general corporate operating revenue in the City's budget. This significantly reduces the tax burden (by approximately 9%) of City ratepayers. The amount in excess of \$17.75 million will be transferred to the General Capital Reserve Fund to assist in addressing the infrastructure deficit. The estimated uncommitted balance in this reserve fund is \$0.77 million.

Both the Performance Dividend and Special Dividend are transferred to the Renew Thunder Bay Reserve Fund. This provides Council with the ability to address existing and emerging capital infrastructure investment and leveraging opportunities.

Since the formation of the Municipal Service Board in 2004, Tbaytel has provided \$297 million to the City of Thunder Bay as outlined in the chart below:

CONCLUSION

It is concluded that City Council should approve the revised Dividend Policy as contained within this report, which serves as a direction to the Tbaytel Municipal Services Board for purposes of payment of future dividends.

It is also concluded that a review of the Dividend Policy should occur every two years and that the next review should be in conjunction with the Third Quarter update from Tbaytel in 2021.

It is further concluded that the Performance Dividend and Special Dividend should continue to be directed to the Renew Thunder Bay Reserve Fund and that the amount in excess of \$17.75 million of the Fixed Annual Dividend be transferred to the General Capital Reserve Fund.

BACKGROUND

Since the formation of the Tbaytel Municipal Services Board in 2004, the total dividend provided to the City of Thunder Bay (for the years 2004 to 2019) amounts to \$297 million, representing a significant return on investment to the community.

RECOMMENDATION

WITH respect to R 178/2019 (Revenue) we recommend that the 2020 interim tax levy be established at 50% of the 2019 final tax obligation;

AND THAT the 2020 interim tax levy be due in two installments, March 4 and May 6;

AND THAT any necessary by-laws be presented to City Council for ratification.

EXECUTIVE SUMMARY

This report recommends an interim tax levy and due dates for 2020.

DISCUSSION

The *Municipal Act, 2001* provides that the interim levy shall not exceed 50% of the total amount of taxes for municipal and school purposes levied on the property for the previous year. In addition, taxes may be billed with a requirement that payment be made in the series of installments.

The City of Thunder Bay has historically offered tax payments in four installments, two each for both the interim and final levy. The main advantages of installment billings are:

- 1. They reduce the cost of current borrowing (or reduce amount of lost interest income) if combined with the use of an interim levy;
- 2. They provide convenience to taxpayers so that they may budget payments;
- 3. They provide steady cash flow; and
- 4. They reduce tax delinquency by provision of earlier payments in the year.

Consistent with prior years, Administration is recommending an interim levy of 50% of the 2019 final property tax obligation with installment due dates of March 4 and May 6, 2020.

Under the terms of By-laws No. 276-1990 and 277-1990, penalty and interest of $1 \frac{1}{4}$ % (15% per annum) is charged the first day of default and the first day of each calendar month that default of payment continues.

Tax payments are accepted at the following locations:

- 1. Canadian financial institutions
- 2. Cashiers Victoriaville Civic Centre

Options for making payments include the following:

- 3. Cash, cheque, debit card, mail, or by credit card through a third party service provider
- 4. Electronic tele-pay and internet banking systems from one's residence
- 5. Pre-authorized monthly equal-pay plan using automatic bank debit
- 6. Pre-authorized automatic bank debit on the due date
- 7. Mortgage companies

In 2019, there were 44,400 tax accounts, which generated approximately \$225 million in municipal and educational taxes.

FINANCIAL IMPLICATION

An interim levy will raise approximately \$112,500,000 over two installments.

CONCLUSION

It is concluded that an interim tax levy is beneficial to both the taxpayer and to the Municipality and should be approved.

BACKGROUND

Section 317 of the *Municipal Act* provides authority for Council to levy interim taxes in advance of the adoption of the estimates and tax rates for the year. The interim levy is required to provide cash flow to meet current requirements.

Evergreen provides basic needs to youth at risk living in our community, services that are regrettably in too great a demand. To be able to meet that demand Evergreen, its Board of Directors are constantly seeking out funding, conducting fund raising activities and advocating with appropriate levels of government for financial support.

The City of Thunder Bay has a long relationship with Evergreen providing funding for on-going operation through the Community, Youth and Cultural Funding Program. Regardless of the support from the City of Thunder Bay, Evergreen continues to struggle to meet the financial demands that they face and this has been compounded by the loss of the access to funding by the discontinued Community Social Reinvestment Program from TBDSSB.

The Environment Division – Water Authority has continued to demonstrate its commitment towards continual improvement of the Drinking Water Quality Management System (DWQMS) for the City of Thunder Bay Bare Point Water Treatment Plant and Distribution Subsystem.

Report No. 84/2015 (Environment) authorized the continued designation of the General Manager – Infrastructure and Operations as the Owners Representative for the City of Thunder Bay DWQMS. As such, the 2018 Annual Management Review Report for the Bare Point Water Treatment Plant and Distribution Subsystem has been completed and presented to myself, as the Owner's designate. The annual Management Review evaluates the suitability, adequacy and effectiveness of the DWQMS and includes a review of the internal and external audits results, water quality results, operational performance and a review of system infrastructure as a highlight. The Management Review Report outlines the results of the Management Review and identifies corrective actions to support continual improvement of the system including specific action items, time lines and personnel responsible.

My review of this report finds that the Water Authority has demonstrated the continued delivery of high quality safe drinking water and their commitment to continual improvement. The external audit carried out by SAI Global in September 2019 confirmed the Water Authority is implementing an effective process for the continual improvement of the management system through the use of the quality policy, quality objectives, audit results, data analysis, the appropriate management of corrective and preventive actions and management review. The objective of the external audit was to determine whether the DWQMS conforms to the requirements of the Ontario Ministry of the Environment & Climate Change Drinking Water Quality Management Standard (Version 2).

In 2018, Thunder Bay was one of the first municipalities to successfully transition to the new Drinking Water Quality Management Standard (Version 2) and the external audit carried out in 2019 confirms the DWQMS remains effectively implemented, meets the requirements of the standard and recommends continued certification. Further, the City of Thunder Bay received an inspection score of 100% from a detailed inspection of the drinking water system carried out in September 2019 by the Ministry of the Environment, Conservation and Parks.

The Statutory Standard Duty of Care under the Safe Drinking Water Act (SDWA) requires system owners to be aware of the Quality Management System (QMS) for its drinking water system and its Committee of the Whole - December 16, 2019 components. Training for Members of Council on drinking water and statutory responsibilities for decision-makers under the Safe Drinking Water Act, 2002 was provided on April 23, 2019. Reendorsement of the City of Thunder Bay Operational Plan by Council was obtained through R93/2019. The Operational Plan documents the DWQMS and is based on meeting or exceeding the requirements of the Ministry of the Environment, Conservation and Parks' (MECP) Drinking Water Quality Management Standard (DWQMS).

The purpose of this memorandum is to provide an information update to City Council on the Provincial Municipal Hazardous or Special Waste (MHSW) Program.

The MHSW Program allows Ontario residents to safely dispose of household products that require special handling, such as single-use batteries and propane tanks. Industry stewardship organizations are responsible for recovering additional hazardous waste products, including automotive materials; paints and coatings; pesticides and solvents and fertilizers.

The Minister of the Environment, Conservation and Parks has directed Stewardship Ontario (the industry funding organization that operates Ontario's MHSW program) to wind-up the MHSW Program to enable the transition of hazardous or special waste to individual producer responsibility under the new provincial regulatory framework.

Under the MHSW Program, Stewardship Ontario (SO) manages the supply chain operations for single-use batteries and pressurized containers. Wind-up for single-use batteries is scheduled to take place on June 30, 2020 with the remaining MHSW materials occurring on June 30, 2021.

The City of Thunder Bay operates one full-time Household Hazardous Waste (HHW) Depot located at the Thunder Bay Solid Waste and Recycling Facility. The City entered into a formal agreement with SO back in 2012 for management of materials at its HHW Depot. Since that time, several amendments to original agreement have been entered into as the program has evolved. The revenue the City receives as a result of this agreement with Stewardship Ontario is approximately \$13,000 annually. Page 2

In anticipation of the wind-up plan being approved, changes to the current Municipal Agreement are necessary to enable SO to make financial payments to municipalities for materials that will continue under the MHSW Program after June 30, 2020, namely pressurized containers. The City will be entering into an amending agreement with SO to ensure these financial payments continue.
