5.0 LIAISON UPDATES

5.1 DULUTH, MN

Border Cats

Mr. Robert Eady noted that the May 28, 2019 event was a success. All feedback received from the community was positive. Information relative to the Committee was relayed to those in attendance and the banner was set up at the event.

The event included Councillor Andrew Foulds as Acting Mayor throwing the first pitch, half time draw, McGillivray Pipe Band and flags from each sister city flown outside of the stadium.

International Day of Peace

Mr. Robert Eady noted that the September 21, 2019 event will include participation from local Rotary Clubs and that a further update would be provided at the August Committee meeting.

Tai Chi – Tour Bus Group

Councillor Peng You noted that the event was a success. The group that visited Thunder Bay enjoyed the itinerary and provided only positive feedback. The event received some media coverage and in addition the group and potentially others will return to Thunder Bay for the 150 celebration

<u>Chef Exchange – Sister Cities</u>

Mr. Matthew Villella noted that the event was a success. The event will take place again in 2020. It was also noted that the restaurants involved will take on more of the planning and the Committee will although be involved, will take a step back.

5.2 GIFU CITY, JAPAN

ECE Teachers Exchange Program

Ms. Hiroko Bekki-Moller noted that two teachers from Gifu have completed their stay in Thunder Bay at Woodcrest School (June 17 to July 2, 2019) and that the two teachers from Thunder Bay will be in Gifu July 13, 2019 to August 1, 2019.

It was noted that upon the teachers return a follow up/debrief meeting will be set up relative to the exchange and that the local teachers will be invited to a fall meeting of the Committee relative to providing a brief presentation on their exchange to Gifu.

Mr. John Hannam noted that the support and participation from the Lakehead Public School Board is appreciated.

Mr. John Hannam provided an update relative to the developing sister school initiative between schools in Gifu and Woodcrest School locally.

Artwork Exhibition

Ms. Hiroko Bekki-Moller noted that the exhibition has been postponed until the Fall of 2019.

Peace Bell Ceremony

Ms. Hiroko Bekki-Moller noted that she is working on the annual event that will take place on Tuesday, July 9, 2019 at 11:30 am at City Hall and encouraged all Committee members to attend.

5.4 <u>SEINAJOKI, FINLAND</u>

Mr. John Hannam noted that he has been in discussion with Mr. Norm Gale, City Manager, with respect to staff exchanges. It was noted that there is potential to hold staff exchanges at the same time or in coordination with a potential delegation from Thunder Bay to Seinajoki in the Fall of 2019.

5.5 JIAOZUO, CHINA

Councillor Peng You provided an update relative to the following:

High school exchange

It was noted that a high school exchange is currently being explored for students from China to come to Thunder Bay.

International Tai Chi Conference

It was noted that connections have been made between Lakehead University and Henan Polytechnic University.

World Tai Chi Championships

Councillor Peng You noted that he is working towards bringing the event to Thunder Bay in 2022.

It was also noted that a tai chi tourism convention is upcoming in Jiaozuo in September of 2019 and that Committee should expect an invitation to attend.

Beijing Winter Olympics 2022

It was noted that application has been sent in relative to involvement from Thunder Bay in the opening ceremonies.

Hockey summer training camp

Councillor Peng You and Councillor Cody Fraser are also exploring a hockey summer training camp.

Councillor Peng You advised Committee that he will be travelling to Jiaozuo in September and attending the opening ceremonies of the Tai Chi and Tourism Convention being held on September 16, 2019.

Councillor Peng You also advised that he is working on a connection with a local Thunder Bay business and representatives in Jiaozuo relative to the tire industry.

Councillor Peng You respectfully asked Committee to provide funding from the Sister Cities budget to aid in the visit to Jiaozuo relative to airfare and accommodations.

It was also noted that the visit will include connections with the Business Improvement Associations, scout groups, Rotary Clubs, and that the Red Lion would be interested in hosting the delegation for dinner.
