We are writing today on behalf of the Thunder Bay and Area Food Strategy (TBAFS). TBAFS brings local food stakeholders together to provide a coordinated approach to achieving food security through the implementation of research, planning, policy, and program development. Our mission is to create a healthy, equitable, and sustainable food system that contributes to the economic, ecological, and social wellbeing.
