	If your property is fenced, are gates routinely locked?

MAKE YOUR HOME SAFER FROM CRIME.

Don't let your property become a target.





WHAT IS CRIME PREVENTION THROUGH ENVIRONMENTAL DESIGN (CPTED)?

CPTED is a proactive crime prevention approach that enhances safety by influencing the physical environment. The environment directly affects our behaviour, whether or not we are aware of it, because we constantly respond to what is around us.

CPTED works by reducing or eliminating criminal opportunities or unwanted behaviour in and around your property. By doing so, it can make us feel safer and help improve our quality of life.

Applying CPTED will help make your property a less appealing target for crime.

What can I do to protect my property?

CPTED does not have to be expensive or difficult to apply. It simply involves taking full advantage of your property’s **natural surveillance, access control, and territoriality potential.**

NATURAL SURVEILLANCE *increases visibility*

This is central to CPTED and refers to the way physical features, activities and/or people are organized to achieve maximum visibility.

ASK YOURSELF:

- Does landscaping or fencing obscure the view to my property from neighbouring properties?
- Are there any areas around my doors or windows where a person could hide?
- Are there areas of contrast or shadow around my property where intruders can loiter without being seen?

WHAT YOU CAN DO:

- Property address should be visible from street and ideally backlit with numbers at least 5” in height.
- The front door should be visible from the street and driveway without any foliage blocking view.
- Windows on all sides of the house should provide full visibility of property.
- Sidewalks & all areas of the yard should be well lit during darkness.
- Properly maintain landscaping shrubs to be no higher than 36 inches and tree canopies no lower than 7 ft to provide maximum viewing to and from the house.
- Use automatic lighting inside the home as well as around the exterior of the property.

ACCESS CONTROL *restricts access*

This refers to measures that limit access to property, create a perception of risk to offenders, and deny them access to targets. This will discourage crime and disorder.

ASK YOURSELF:

- Do people routinely trespass on my property and/or fence line?
- Can people trespass on my property without being seen by others?
- Do any existing access routes lack natural surveillance?

WHAT YOU CAN DO:

- Attractive porches and walkways of stone, concrete and brick act as transitional areas to direct visitors to the proper entrances & away from private areas.
- Use metal tubular gates and fences or fences made of materials where visibility is heightened.
- Keep trees or exterior buildings from roof and 2nd story balcony or windows access.
- Use alarms at gates, doors and windows, where appropriate.
- Have and use a 180° peep hole.
- Place thorny plants under windows and other vulnerable spots.

TARGET HARDENING & TERRITORIALITY *promotes a sense of ownership*

Target hardening refers to the direct physical strengthening of space to reduce its vulnerability to entry by unauthorized persons. Territoriality uses physical features and activities to express ownership and control of the environment.

ASK YOURSELF:

- Is my property used as a short cut?
- Does my property ever have an unlive-d-in or unkempt appearance?
- Are there seldom-used sections of my property where people loiter?

WHAT YOU CAN DO:

- Mark property boundaries with hedges, low fences, or gates.
- Create recreational use for yard spaces and encourage its use.
- Exterior doors should be hinged on the inside and should have at least a single cylinder dead bolt lock.
- Door locks should be located at least 40 inches from adjacent windows.
- Avoid glass in exterior doors. If necessary use polycarbonate or burglary resistance glazing.
- Interior doors that connect a garage to a building should have at least a single cylinder dead bolt lock.
- All windows should have locks.
- Sliding glass doors should have one permanent door on the outside; the inside moving door should have a lock with and additional locking pin.

Maintenance is a key aspect of territoriality
