



TO CONSTRUCT A FENCE TO ENCLOSE A PRIVATELY OWNED/OPERATED SWIMMING POOL

PRIOR TO COMPLETING THIS FORM CAREFULLY READ THE ATTACHED BY-LAW (254-1974: SWIMMING POOL FENCE) AND THE ZONING BY-LAW EXCERPT.

NOTE: WHERE WATER DEPTH EXCEEDS 3.5 METRES (11'-6") AT ANY POINT, A BUILDING PERMIT IS REQUIRED TO CONSTRUCT THE POOL.

In addition to this form, a permit application form must be completed and a site plan submitted showing property dimensions, building(s) size(s) and locations, location and size of proposed pool, and location of fence enclosure for which this application is made. Proof of ownership is also required – (Copy of a Tax Bill or Deed)

SWIMMING POOL LOCATION – ZONING REGULATIONS

- Cannot be located in a front yard or exterior side yard
- Walls of Pool to be a Minimum of 1.5 metres (5 feet) from any Interior Side and Rear Lot Line
- Filters, pumps, or similar operating equipment, whether open or enclosed, must be a minimum of 0.6 metres (2 feet) from any lot line and 3.0 metres (10 feet) from any main building

POOL DETAILS

- A** ABOVE GRADE MAXIMUM DEPTH _____ INCHES
- Walls of pool may act as the pool fence provided they are a minimum of 48" high and are non-climbable
 - The ladder/stair into the pool must be fenced separately complete with gate. Choose 'Fence Type' and 'Gate' below for ladder/stair enclosure
 - The above will be used as the pool enclosure **OR**
 - The above will **NOT** be used. A separate fence will provide the enclosure as shown below

FENCE DETAILS

- Fence Height _____
- Fence Posts and other Structural Members to be located on Pool Side
- Fence shall not Facilitate Climbing
- Bottom of Fence to be at Grade Level
- Fence shall be located not less than 4 feet (1.2 metres) from the Edge of the Pool
- Building Wall, if used as Fence, to be 1.5 metres (60 inches) minimum in height Applicable Not Applicable

FENCE TYPE

Complete A or B, **or** A and B below, as applicable

- A** CHAIN LINK – choose i) or ii) below, read and acknowledge iii), iv) and v)
- i) - 1 ½ maximum diamond mesh (required for fence height between 48" and 72")
 - ii) - 2" maximum diamond mesh (required for fence height 72" and greater)
 - iii) - fence material 12 gauge or heavier, as required by by-law
 - iv) - taut wire interwoven through bottom links of entire fence
 - v) - metal posts set in concrete and spaced not more than 10 feet apart
- B** WOOD
- Minimum 48" in Height
 - Boards will be placed vertically and spaced not more than 11/2" apart as required by by-law
 - Lattice **NOT** permitted

GATES

- Number of Gates _____
- Equipped with Self-closing and Self-latching Devices
- Self-latching Devices to be located at Top of Gate on Pool Side

BACKFLOW PREVENTION DEVICE shall be selected and permanently installed in accordance with CAN/CSA-B64.10 at the source of the domestic water supply (such as a hose bib) used to fill and/or service the pool.
